MosChip Q3 and 9 Months FY 2022-23 Update

Moschip Technologies continues to focus on Semiconductor / Embedded design services, Turnkey ASIC solutions, Semiconductor IP (Intellectual Properties) and IOT projects which have been enabling steady and sustainable growth.

Consolidated Financial performance

Q3 FY 2023 vs Q2 FY 2023

- Income from operations increased from Rs 49.15 crores to Rs 53.70 Crores an increase by 9%
- There is an increase in EBIDTA from Rs. 6.57 crores (13.0%) to Rs. 8.14 crores (15.0%), this is on account of increase in revenues.

Q3 FY 2023 vs Q3 FY 2022

- Income from operations increased from Rs 38.29 crores to Rs 53.70 Crores an increase by 40%
- EBIDTA increased from Rs. 6.38 crores to Rs 8.14 crores, an increase by 28%.

9 Months FY2023 vs 9 Months FY2022

- Income from operations increased from Rs 110.23 Crores to Rs.144.52 crores, an increase by 31.1%.
- EBIDTA increased to Rs 21.75 crores as against Rs 17.33 crores, an increase by 25%.

The Group EBIDTA and PAT are 15% (Rs 21.75 crores) and 3% (Rs 4.66 crores) respectively.
